RAPID RE-HOUSING PROGRAMS: THE HOUSING SERVICES PROGRAMS WERE DESIGNED TO MOVE FAMILIES INTO PERMANENT AND INDEPENDENT HOUSING AS QUICKLY AS POSSIBLE, AND TO ASSIST AT-RISK FAMILIES TO AVOID EVICTION. HOUSING SERVICES IS COMPRISED OF TWO INTERRELATED PROGRAMS HOUSING SOLUTIONS AND HEADING HOME. THE TRANSITIONAL HOUSING PROGRAM GIVES FAMILIES TIME TO IDENTIFY AND ADDRESS THE CAUSES OF THEIR HOMELESSNESS. FAMILIES ARE PROVIDED ONGOING CASE MANAGEMENT, COUNSELING, EDUCATIONAL AND RECREATIONAL PROGRAMS FOR CHILDREN, ADVOCACY, WORKFORCE DEVELOPMENT RESOURCES, AND OTHER COMMUNITY-BASED REFERRALS. FAMILIES RECEIVE WEEKLY CASE MANAGEMENT TO IMPROVE BUDGETING, PARENTING SKILLS, AND OTHER LIFE SKILLS WHILE PREPARING FOR ECONOMIC AND HOUSING STABILITY. IN NOVEMBER 2015, HAMILTON OPENED A SECOND TRANSITIONAL HOUSING PROGRAM IN SAN FRANCISCO, TO HOUSE UP TO SEVEN FAMILIES EXPERIENCING HOMELESSNESS WITH AN OPEN CHILD WELFARE CASE THROUGH THE DEPARTMENT OF CHILDREN, YOUTH
